## Data entry-supplemental distance learning

- On Adult Details page
  - Check the Distance Learner checkbox
  - Select "Provided by Local Program"
- Class to record supplemental distance learning participation
  - Service = Distance Learning
  - Special Program Type = Distance Learning
- Do not add hours in students' face to face classes

#### Data entry: volunteer classroom aides

- Must enter all volunteer classroom aides
- Must enter classroom aides' time
- Assign aides to classes to enter and track hours
- Staff Details>Primary Position = Adult Education Paraprofessional



### Data entry: Assessment

- Initials for assessment
  - Person who administered the assessment
  - Must match the staff person's name as entered in Staff Details section



#### Data entry: corrections education

- Adult Details
  - Residence = Institution
  - Ex-offender = No
  - If "Reason for leaving" is "Release from incarceration," should also have date in "Incarceration Release Date"
- Class/Group/Pair
  - Contract-Program Component = Institutional



#### Data entry: optional items on Adult Detail

- Reason for Leaving: enter if known
- PA CareerLink Referral: If the student accessed your services through the PA CareerLink, select Yes



#### 2019-20 grants: 054 and 099

- Family Literacy 054 and State Leadership 099: renewal grants/1-year grant contract
  - Narrative: Copy and paste from 2017-18 grants
  - Applicant Information and budget: update to reflect 2019-20 activities
  - Requires authorized sign off/signature page
- Actual award amounts TBD



### 2019-20 grants: 064 and 061

- Year 2 of 4-yr (064) or 2-yr (061) contract
- eGrants
  - No Narrative section: Narrative from grant competition binding for duration of contract
  - Agency Information: update for 2019-20
  - Budget: update for 2019-20
    - Local match
      - Has its own section
      - Must identify if cash or in kind



### 2019-20 grants: 064

#### Awards

- Funding notification will be sent by June 1
- Level funding, same contracted enrollment
- Possible conditions on the grant based on
  - Actual enrollment using data entered by 4/15
  - % of students who had been posttested who had an EFL gain using data entered by 4/15
  - Optional Tutoring Program: conditions based on number of tutors, pairs and groups as compared to the number proposed in the grant



#### 2019-20 grants: 061

- Level funding, same contracted enrollment
- Must address all issues identified by the advisors
- Participation in required PD
